RiskWise

Integral to BMO Real Estate Partners's strategy implementation is their use of the RiskWise risk management system.

RiskWise is used to manage almost 100 properties in the BMO Real Estate Partners portfolio, and provides detailed risk tracking, management and reporting for a range of users including directly employed building managers and external managing agents.

RiskWise was chosen predominantly for its flexibility and simplicity of use - the '3-click rule' providing all users easy access to the data they need.

Before RiskWise, reporting had been a time-consuming task for BMO Real Estate Partners – with performance analysis requiring manual collation and interpretation of data. Now instantly available at the click of a button, BMO Real Estate Partners have benefited from reduced administration, accurate reporting and transparency of performance.

RiskWise provides a robust document and activity management facility and ensures all required risk management actions are raised, allocated for action and resolved – providing a full audit trail and real-time building performance monitoring. RiskWise is also used to store essential policies and documentation ensuring each property is prepared for inspection.



By improving visibility of issues and deficiencies, each building manager has the capability to escalate or clear down risk management actions.
